Charitable Incorporated Organisation

On the 8th October 2018 our CIO Constitution was given to us by the Charity Commission and, as discussed at the October AGM we need to have full membership approval to implement it.

Before we can do this we have various legal matters concerning the Pond Lease to resolve with the Owners' trustees and are preparing to approach a specialist firm of solicitors for help with the technicalities.

Infrastructure

Pond Draining

We drained the pond and opened the gates on 24th January for several days taking advantage of the Spring Tides to flush out silt. We had previously approached the Environment Agency to redirect the flow at Constant Spring to increase the scouring process, but they were unable to act within the timeframe.

They have now responded that they are not prepared to adjust the sluices to increase the flow in the Lumley Brook unless there is a significant increase in the flow of the River Ems. They fear that causing a lower flow in the Western branch could strand fish and seriously affect the ecosystem. Comments about the ponds' 'silting up' in the last 40 years are most intriguing – in 1977 (about 40 years ago) when the tidal gates were renewed, we were required by the authorities to lower the impounded water level by 9 inches - equivalent to a sudden dump of silt across both ponds.

Reeds have taken advantage of the major change in base level, however their spread now seems almost in equilibrium. When the water levels are

dropping the main channel carries flow but the flanks drain in gentle dribbles and very little silt is carried away.

Unfortunately flushing is only likely to work when flows are very significant, so we will continue to open the gates under appropriate conditions.

Tidal Gates

The worm growth and build-up of barnacles have been removed and, whilst not perfect, the seals should stem any leakage better.

Whilst the pond was drained the sluice structure was inspected and found to need serious attention in the near future. The picture is taken looking upwards from the pond side and wear on the groove rebate can be clearly seen.

A specialist is being approached to quote for the work.

Footbridge railings

As reported last September the existing balustrades are showing the ravages of time .

Various solutions to the problem have been explored, for example, replacing the posts using steel pads bases etc. We have written to four structural engineering practices for support with a possible redesign but have had no real success so far.

In discussion with the WSCC Public Rights of Way Section, we have been advised that any solution other than a direct replacement would involve a full technical approval; we have been offered a grant of £200 towards the works.

Considering the lack of response from the engineers and the fact that their solutions will require significant outlay, we are getting quotes for refurbishment rather than replacement. Hopefully we will instruct a contractor to start in the very near future so that the bridge will be resplendent for the Spring.



Northern Bird Raft

The windy weather in the autumn caused the raft to rotate and twist its anchor chain into a tight ball, thus setting it free. On the last weekend in January we caught up with it, fitted a new anchor and chain equipped with a swivel and refixed the coot house roof.

The task was carried out by doughty SMPPA volunteers and was not without incident. Passers-by were concerned that all should return to shore safe and well, as at one point the two dinghies in attendance had abandoned one poor soul on the raft!

Reeds

As noted in the September Newsletter our efforts to control the spread of the Common Reeds (*Phragmites australis*) continue. If left unchecked they will continue to spread over the banks and Slipper Road, creating a potentially dangerous reduction in sight lines for walkers and drivers of vehicles. Their rhizome system is invasive and has caused the road surface to crack in the past. By controlling them we are <u>seeking a balance</u> between providing a habitat for wildlife and safety for all.

The reeds can grow to a height of 4 metres and perhaps if we had our time again they would not have been planted!! – Never mind, they were and we need to deal with them.

The committee is in contact with a specialist contractor EnviroAqua (<u>www.enviroaqua.co.uk</u>) who are recommending spraying the reeds when the growth is about 30cm to 60cm high, and importantly after they have undertaken all necessary paperwork in order to apply to the Environment Agency for an AQHERB01, permission for spraying. They have advised as follows:-

"... Enviroaqua has had an extremely good success rate cutting Phragmites and spraying the regrowth. Slipper Mill Pond Preservation Association have cut areas of vegetation back prior to spraying treatment. Some marginal vegetation has not been cut and all attempts will be made to spray this area as effectively as possible. Treatment of the Phragmities will be using Roundup Pro-Bioactive. This is a non-selective Glyphosate-based product safe to use by our qualified personnel around aquatic environments."

As Roundup Pro-Bioactive is a non-selective Glyphosate-based product there will be collateral damage to the immediate vegetation but <u>this will</u> <u>recover</u>. Great care will also be taken to avoid wildlife especially any birds nesting.

Signage

Warning signs in pond are to be removed and replaced by pictogram panels fixed in strategic positions

The Information Panels at the head of the pond and on the wall of Slipper Mill are being reviewed at present and a revised panel is being discussed.



Wardle Land

We continue in discussions with the Wardle family who are prepared to gift the Association with the land which includes the public footpath on the West side of Dolphin Creek. We are looking at details of the lease for access to the adjacent moorings and, at the same time, thinking carefully about the commitment and bearing in mind potential future Committee strength.

Westwood Development

The Planning Application (Ref: APP/18/00672) has been submitted to Havant Borough Councils and the following objection lodged on behalf of the SMPPA

1. Flood Plain

Reducing the flood plain potential of land to the North the A27 so affecting flows and flooding downstream.

2. Surface water drainage

High local ground water level impeding efficiency of a storm-loaded SUDS system creating pollution risk.

3. Ecological corridor

Valuable 'green' through routes from the Downs to the Sea are being eroded by the many intrusive development proposals clustered close by in both Havant and Chichester Council Areas.

4. Impact on the local infrastructure

Ever more housing in the area overstressing underlying systems such as: educational, medical, employment as well as transportation facilities in the area.
